re: Immoral acts involving Robert Daniels

On several occasions Bob Daniels, while "double bunking" with a member of the post, made immoral advances. At some time this reached the point of his placing his hand or mouth on the boy's penis & causing orgasm.

Specifics -

On two occasions, the complainant was molested by Mr. Daniels while on Post activities & while sharing common sleeping accommodations. On one occasion this was done manually. On the second occasion, complainant awoke to find Mr. Daniels' mouth on his penis. Complainant was 14 - 15 during this period.
