This is a response to Mr. Anthony Gibbs' inquiry regarding a different middle initial that we are reporting on Mr. Burns.

In reviewing his file, Mr. Burns has the same date of birth and the name is the same with the exception of the middle initial. He was placed on the Ineligible Volunteer File in the Chicago Area Council in 1967.

According to our records, the Chicago Area Council reported on June 16, 1967 Mr. Burns' middle initial as being 'W'. Our records also show that on April 23, 1990 his middle initial was reported as being 'P' by the Chicago Area Council. Because the original correspondence from the council indicated that his middle initial was 'W', we feel that the council made a mistake on the April 23, 1990 correspondence. We still believe that he is the same person that is on the Ineligible Volunteer File; therefore, we are requesting that the council follow through with the correspondence with Mr. Burns informing him that he is on the Ineligible Volunteer File and he should sever all relationships with the Boy Scouts of America.

EXTRACTS FROM THE CHARTER AND BYLAWS

Granting Commissions and Certificates of Membership

All persons serving in any official relationship with the Boy Scouts of America shall subscribe to the statement of religious principle. . . the Scout Oath and Law, and these Bylaws. Such persons shall be citizens of the United States, or . . . shall have legally declared their intentions to become citizens of the United States, or, in the case of minors, shall take an oath of allegiance to the flag and Government of the United States, or shall satisfy the requirements of Article XVI, Section 6, Clause 4 with respect to visiting adult allens. Article XVIII, Section 2.

Character Development, Citizenship Training, Mental and Physical Fitness

The purpose of the Corporation is as set forth in the original certificate of incorporation under the laws of the District of Columbia, dated February 8, 1910, and restated in the Act of Incorporation enacted by the Congress of the United States of America on June 15, 1916, as follows: "That the purpose of this corporation shall be to promote, through organization, and cooperation with other agencies, the ability of boys to do things for themselves and others, to train them in Scoutcraft, and to teach them patriotism, courage, self-reliance, and kindred virtues, using the methods which are now in common use by Boy Scouts." In achieving this purpose, emphasis shall be placed upon its educational program and the oaths, promises, and codes of the Scout program for character development, citizenship training, mental and physical fitness. Article I, Section 2.


