Enclosed is a local newspaper article that attracted my attention, especially the last sentence.


According to Investigator Dick Mills, Anchorage Police Department, the 40-year old man whose identity was not released is actually KENNETH A. BURNS, DOB 1-12-51. I understand he was court martialed by the United States Air Force in Fairbanks, Alaska in the early 1980's and placed on our undesirable listing at that time.

Since he is again "active" I thought you needed to be alerted. It is my understanding that when he fled Anchorage he landed in New Mexico, I believe Albuquerque, but I'm not absolutely sure.

During my conversation with Dick Mills, he restated his comment that Burns looks like the stereotypical abuser, if there is one! If we can provide the training we have available for our youth maybe we can give them the ability to recognize this guy where ever he may show up. Since he seems to be running and has had a past involvement with Scouting, we need to be alert.

Suspected molester flees as police investigate

A man who befriended children and their parents and stocked his Muldoon mobile home with kids' games is under investigation by Anchorage police, who say he molested more than 100 young boys.

Police would not release the identity of the 40-year-old man, who fled the state about three weeks ago after police searched his home. At

the time, police did not have enough evidence to arrest him.

As early as 1986, investigators began watching the man after neighbors and school officials complained that young boys were hanging around his home.

Police said that during their investigation, they have accumulated several accounts of sexual abuse involving the man. Police said most of the man's victims

were between 6 and 12 years old. One victim, who police recently tracked down and is now a young man, told investigators the man abused him in 1974.

Sgt. Joe Austin, head of APD's crimes against children unit, said the man was convicted in a military court of sexually abusing a minor in 1980 while he was stationed at Eielson Air Force Base near Fairbanks.

Police are now building a

case against him for his activity in Anchorage and say they will ultimately track him down and arrest him. But so far, police have not issued a warrant for his arrest.

"This is a fairly difficult case. You have a large number of victims," Austin said Friday. "The difficult thing is getting the kids to talk about it. A lot of them don't realize anything was wrong."

In fact, when police took evidence out of the man's home, several young boys sat in front of the police van, blocking their way in protest.

"He was real nice to these kids: He would buy them things," Austin said.

He said the man's abuse of the children was slow and subtle. First, he would befriend them and buy them toys. Then he would invite them into his two-bedroom

mobile home, equipped with oak bunk beds, three televisions and Nintendo video games.

His bedroom shelves were stacked with thousands of comic books.

"This place was a garbage dump to me. But to a 10-year-old, this was heaven," said Anchorage police investigator Dick Mills, who

searched the home for evidence.

According to police, the man would videotape the boys and play sexual games with them, sometimes touching their genitals. But police have no evidence he had sexual intercourse with any of them.

On one occasion, police said, he video taped sexual activity between a young

girl and two boys. When police found out about it and questioned him in March, the man said he had no idea the children were having sex.

Mills said the man told him that he had gone to bed early and left the video camera on to make sure the kids would behave themselves. When he discovered what was on the tape, he immediately erased it, he told police.

Mills said the man, whom

he described as stocky, was "deceptive" on a lie detector test. "He's a very manipulative person," he said. "He plays on your emotions and your feelings a great deal. During the polygraph, he whined a lot."

The Muldoon molester "looks the part" of a man with a perverse sexual appetite, Mills said. But many child abusers fit naturally into any situation and don't alarm parents, police said.

Despite his appearance, police said, parents even trusted the man enough to allow their children to spend the night at his home and go camping and sailing with him.

When he fled Anchorage, the man quit his job, deserted his home and left his sailboat behind. From evidence they collected in his home, police said the man is a war buff and former Cub Scout leader.

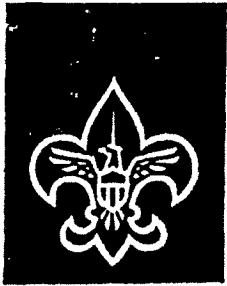



Dear Mrs. McKean

In answer to your letter of inquiry of February 10, 1982, I can only release to you the results of trial of Technical Sergeant Kenneth Burns, Jr. He was tried by court-martial on 9 and 10 December 1981. He stands convicted of wrongfully and willfully permitting and condoning two males under 16 years of age, who were then under his supervision, to engage in sexually oriented activities, which included the wrongful touching of the private parts of the other participant by each of the said minor males.

Whether there is any moral problem or whether Sgt Burns should be allowed to work with boys is a question better left to your agency to answer.

We hope that this information is of assistance to you in making a decision.

Dear John:

This is in response to your letter of June 30, concerning Kenneth Burns of Pack 9.

You indicate that Mr. Burns should be removed from registration with the Boy Scouts of America in Pack 9. We will delete his registration from our records at this time.

I will need more information if you wish me to place him on our confidential file so that he cannot register in the future. I will agree that sleeping nude and showing the boys pornographic books indicated very poor judgement when dealing with cub scouts. I do not know, however, that this is a serious enough offense to refuse registration anywhere he might try to register unless there are more instances.

Please send me a copy of the letter which you received from the Air Force and let me know of other items which you have which would strengthen our files. We would also need a confidential record sheet indicating personal information so that we may be able to identify Mr. Burns in the future.

You do not indicate if you received a resignation letter from Mr. Burns, but if one was written, we would like a copy. Who approached Mr. Burns and asked him for his resignation or how was this handled? All of this information is most important to enable us to maintain a file in our office.


