Dear Paul:

Following up on a conversation with your office on May 10 concerning Lloyd Fish.

In conversations with both Dave Yoquelet of the Marshall County, Indiana, Sheriff's Dept. and Kevin Allen of the Marshall County Probation Office, both indicated that any information regarding Lloyd Fish was confidential and not available to the public.

I did gather from talking to Mr. Yoquelet in January 1991 that Lloyd's problem with the Sheriff's Dept. could be similar to that of [REDACTED]. However, in no way was it ever stated as to the type of offense or what the outcome was.

This whole matter came to light when I tried to secure additional information requested by you regarding [REDACTED]. At that time Mr. Yoquelet indicated that Lloyd also had been involved in what I gathered to be a similar situation. Not having any information on Lloyd I shared this with our Scout Executive, Ron Eagon. He contacted you.

In trying to secure further facts on Lloyd on April 11 I was told by Mr. Yoquelet that due to the subject's age his file was confidential and that I should contact Mr. Allen.

On April 12 Mr. Allen, in a phone conversation, confirmed the confidentiality statement. I asked for a letter to that effect which you now have.

At this point I feel that there is nothing more that I can do to secure additional information.


