Specific Circumstances: [redacted] had his son tell the camp director the following story: [redacted] went with his Wilderness Survival merit badge class to sleep out at their shelters. They were accompanied by their counselor, Mike Wright and Bob Bye. During the night the boys moved into one of the shelters as protection against mosquitoes. [redacted] alleged that during the night Bob Bye put his arm around him several times and toward daybreak reached for his testicles. The boy affirmed that he required the commissioner and that nothing

Action Taken: The camp director called the Chairman of the Camping Committee, Randy Murrill, who in turn contacted Robert Poole, the legal counsel for the Del-Mar-Va Council. It was determined that Commissioner Bob Bye would be temporarily suspended until a full investigation could come to definite conclusions. The Director of Camping agreed to be in camp to witness the first conference with Bob Bye.

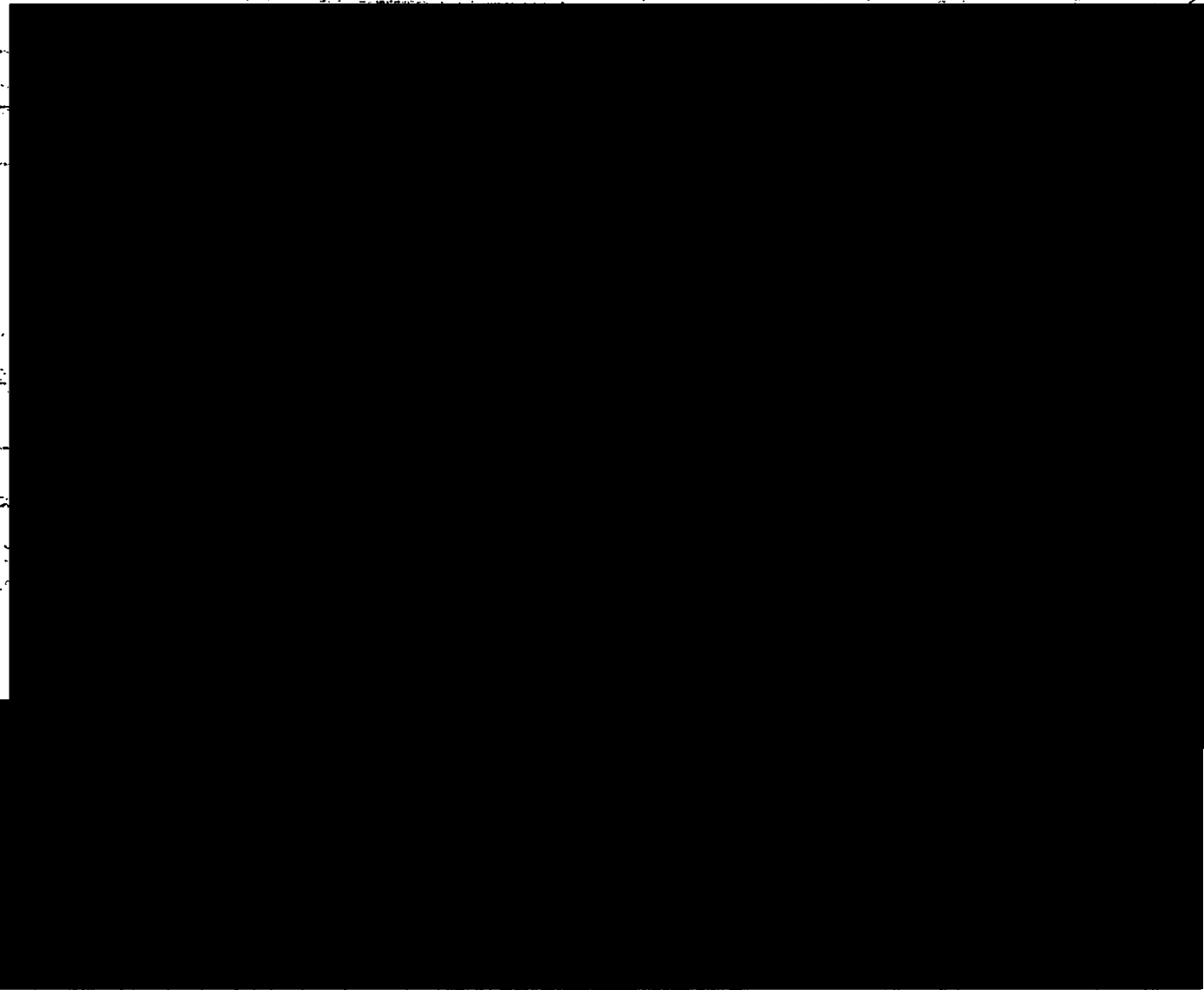

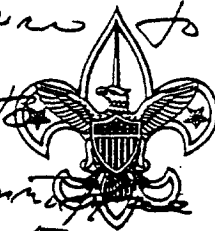
