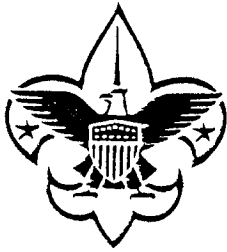

Thanks for your help in completing the file.

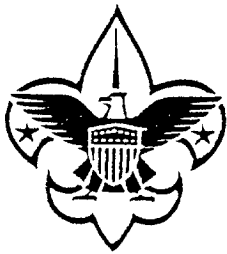
