Men Plead Guilty To Sex Offenses

WALHALLA (rh) — An Oconee County man pled guilty Tuesday in General Sessions Court to committing a lewd act on a child. ~~Jim Carver~~ was sentenced by Judge Howard Ballenger to six

~~years of imprisonment, suspended to three years of intensive probation and mental health counseling, if deemed necessary.~~

~~Carver had been accused of committing the offense against a male child under age 14 between October 1, 1984, and October 31, 1984. He was indicted by the Oconee County Grand Jury on June 12, 1985.~~

~~His plea was negotiated.~~

Also pleading guilty Tuesday was Charles E. Suttles Jr. He had been charged with criminal sexual conduct with minors in the first degree, but pleaded guilty to contributing to the delinquency of a minor.

For that offense, Suttles was sentenced to three years of imprisonment, suspended on 90 days of imprisonment and three years of probation.

Three Seneca men pled guilty to drug-related charges in General Sessions Court this week.

John T. Jones of Route 5, Seneca, pled guilty to distribution of cocaine, conspiracy to violate the controlled substance act and two counts of possessing illegal drugs. He was sentenced for each offense, but the sentences will run concurrently. He will serve a maximum of seven years in prison and will be subject to five

years of probation.

Charles Christian of North Walnut Street, Seneca, pled guilty to distribution of cocaine. Judge Ballenger ordered a pre-sentencing report to be done before Christian will be

James Fletcher Simpson of North Walnut Street, Seneca, pled guilty to the distribution of cocaine and the distribution of marijuana. He receives sentences that will run concurrently. He will serve a maximum of seven years and be subject to five years of probation.

Others pleading guilty included:

Ronald G. Patton of Westminster pled guilty to a second driving under the influence offense. He was sentenced to one year and \$1,000, suspended to 48 hours and \$350 and costs of the court, one year probation and alcohol and drug abuse treatment.

Fredrick Maxwell Harper of James Street, Seneca, pled guilty to a second driving under the influence offense. He was sentenced to one year and \$1,000, suspended on 48 hours service, \$350, costs of the court and alcohol and drug abuse treatment.

Michael Scott of Spring Street, Westminster, pled guilty to grand larceny. Judge Ballenger ordered a pre-sentencing report.

Annette Smith of Coffee Road, Walhalla, pled guilty to disposing of property under lien and fraudulent acquisition of food stamps. She was sentenced for both offenses. The sentences will run concurrently and equal a maximum three years of probation and restitution of \$212.65 and \$1,347.

Donald L. Butler of Tribble Street, Seneca, pled guilty to charges of robbery and attempted armed robbery. He had been accused in the attempted armed robbery of Revco Drugs in Seneca in September. Butler, who has a record of numerous housebreaking charges, was given a sentence of 15 years of imprisonment by Judge Ballenger.

Bobby Eugene Sargent of Route 5, Westminster, pled guilty to a second offense of driving under the influence. He was sentenced to one year and \$1,000, suspended to 48 hours and \$350 and costs of the court, two years of probation,

drug abuse counseling and \$100 to the public defender's fund. Sargent also pled guilty to a first offense of driving under suspension, for which he received a sentence of \$100 or 30 days. That sentence will run consecutively to the other.

Donnie Ray Winkler of Central pled guilty to driving under the influence. He was sentenced to one year and \$1,000, suspended on 48 hours and \$350, costs of the court, one year of probation and drug abuse counseling.

Hugh Dorsey Moss Jr. pled guilty to three counts of breaking into an automobile and one count of breaking into an automobile and grand larceny. He was sentenced on all four counts. The sentences will run concurrently and equal four years of probation, alcohol and drug abuse treatment and restitution for all damages.

Leroy Lynn Green of South Fourth Street, Seneca, pled guilty to a second offense of driving under the influence. He was sentenced to one year and \$1,000, suspended on 48 hours and \$350, costs of the court, one year of probation and drug abuse counseling.

Thomas Edward Moore Jr. of Route 1, Seneca, pled guilty to grand larceny of a motor vehicle. He was sentenced to six years, suspended to five years of probation, restitution of \$200, drug abuse counseling and vocational rehabilitation if necessary.

Judith Harris Allen pled guilty to forgery. She was sentenced to five years, suspended to three years of probation, restitution of \$411.68, vocational rehabilitation and costs of court if necessary.

In a negotiated plea, Larry Thomas Haynes of Fair Oaks Village, Seneca, pled guilty to "strong-armed" robbery. He had been charged with the armed robbery of the Red Diamond at North First and Cherry streets in Seneca. He was sentenced to 10 years, suspended to five years of probation, full restitution and any alcohol and drug abuse treatment deemed necessary.
