I RECEIVED A CALL FROM RANDY MAYFIELD, CAMP DIRECTOR, CAMP HOOD, HAZLEHURST, ON Friday, JULY 17, 1987 AT 10:00 PM. HE INFORMED ME OF AN INCIDENT AT CAMP THE PREVIOUS SATURDAY.

TOLD HIM THAT ON SATURDAY HE SLEPT WITH LAKE DELOACH IN THE SAME BED BECAUSE HE WAS COLD. DURING THE NIGHT LAKE PULLED DOWN HIS UNDERWEAR AND PUT HIS HAND ON HIS PENIS. GOT UP AND SPENT THE REST OF THE NIGHT IN A SEPARATE BED. RANDY INFORMED ME THAT HAD TOLD THE SAME STORY TO THE HEALTH OFFICER MELISSA HANEY. I ASKED RANDY TO CHECK THIS OUT AND CALL ME BACK. HE CALLED ME BACK AT 11:17 PM AND TOLD ME THAT HAD TOLD HIM AND MELISSA THE SAME STORY.

ON SATURDAY MORNING, JULY 18, 1987, I CALLED DON ROBERTS, AREA DIRECTOR, AND INFORMED HIM OF THE SITUATION. WE AGREED THAT I WOULD TALK WITH PARENTS. BEFORE CALLING FATHER, I CALLED FRANK EDMONDS AND TOLD HIM THE SITUATION. HE AGREED THAT WE WERE HANDLING THE SITUATION CORRECTLY.

I CALLED AND ASKED HIM IF I COULD RIDE TO CAMP WITH HIM THAT MORNING. I TOLD WHAT HAD HAPPENED. WHEN WE ARRIVED AT CAMP, TALKED TO AND THEN RANDY. AND I TALKED TO WE TOLD HIM HOW IMPORTANT IT WAS TO BE CORRECT IN WHAT HE SAID.

RANDY AND I THEN WENT TO TALK WITH LAKE DELOACH. HE ADMITTED THAT HE MADE A BAD JUDGMENT CALL AND WOULD NOT DENY WHAT HAD SAID. HE DID SAY THAT HAD TAKEN HIS HAND AND PLACED IT ON HIS PENIS.

WE TOLD LAKE TO GO BACK TO THE DELTA AREA COUNCIL, CLARKSDALE, MISSISSIPPI, AND WRITE A LETTER OF RESIGNATION TO THE DELTA AREA COUNCIL AND NOT BE INVOLVED WITH SCOUTING INCLUDING SUMMER CAMP OPERATIONS ANYWHERE. WE ALSO ASKED HIM TO GET AN APPOINTMENT WITH A COUNSELOR.

SAID HE WAS NOT INTERESTED IN ANY LEGAL PURSUIT OF THIS SITUATION.

THE DELTA AREA COUNCIL DELIVERED A LETTER TO LAKE TELLING HIM HE WAS NO LONGER INVOLVED IN SCOUTING.
